Dancer Agreement

<u>initial</u>	Attend all choreography rehearsals.
<u>initial</u>	During Fall session maintain a 100% attendance in my Ensemble rehearsal classes. And a minimum of 90% in my other required classes. Unless otherwise excused by the Ensemble Director.
<u>initial</u>	I will do my best to reach or exceed the maximum skill level of my team.
<u>initial</u>	I will be mindful of my weaknesses and will utilize my technical classes to focus on overcoming them and creating strengths.
<u>initial</u>	I will have a strong work ethic and will effectively utilize all my dance classes and rehearsals to maximize my dance abilities.
<u>initial</u>	I am aware that being part of an Ensemble team, come with responsibilities to my team and my Director. I understand that <u>ALL</u> Ensemble performances are mandatory.

Parent Agreement

<u>initial</u>	I am aware of the \$450 Ensemble Program Fee. As a courtesy, UDA divides this amount into \$50 monthly payments September – May.
<u>initial</u>	I have provided a \$30 Non-Refundable Commitment Fee. I also understand that my \$100 Contingency Fee will be broken into two payments . 1st payment of \$50 is due on July 1, 2017. 2nd payment is due August 1, 2017. If this fee is not used it will be credited back on my account in May.
<u>initial</u>	I HAVE READ AND UNDERSTAND ALL DATE REQUIREMENTS. My dancer is expected to attend classes beginning August 23, 2017. Classes will be Tuesdays and Thursday, August 22 nd , 24 th , 29 th , and 31 st . I will be charged \$130 for these classes.
<u>initial</u>	Personal information or situations that affect the dancer need to be addressed with the program director immediately.
<u>initial</u>	I understand that there will be extra rehearsals on Tuesdays and some Saturdays.
<u>initial</u>	I understand my dancer will be required to take all their correct Ensemble classes for their level as well as the ballet recital and technique classes for their level and either the recital jazz – OR – recital modern class in the level that they were placed in for the 2017-2018 dance year, in addition to their Ensemble class.
<u>initial</u>	I understand that all Ensemble dancers will be performing in the June 2018 Spring Recital and will be subject to the same costume fee/costume charge as other dances participating in the recital. A recital fee of \$80 is due October 1 st with tuition. A costume fee of \$40 per costume is due December 1 st with tuition. The remaining costume balance is due February 1 st with tuition.
<u>initial</u>	I am aware that my dancer is part of an Ensemble team, and that she has responsibilities to her team and her Director. I understand that my dancer needs to attend <u>ALL</u> Ensemble performances and that they are mandatory.

<u>initial</u>	I HAVE READ AND UNDERSTAND THE FEES SCHEDULE AND FINANCIAL REQUIREMENTS. Including the withdrawal policy contained with this agreement.
<u>initial</u>	I will attend <u>ALL</u> Ensemble meetings to ensure I receive all information, schedules and training and that my child's Ensemble participation is not adversely affected due to my/our absence from mandatory meetings.
<u>initial</u>	I will maintain a working e-mail address, advising the Ensemble program manager with any updates so I may receive all Ensemble communications. I will check this address 2-3 times per week for updates during choreography and rehearsal months, and <u>daily</u> during the performance season. I will provide all information requested throughout the season <u>before required deadlines</u> .
<u>initial</u>	I understand that I will be REQUIRED to volunteer in some capacity during the year. This could include: team photographer, backstage mom, events, performances, etc.
	Mandatory photo shoot will be required for all Ensemble dancers. The photo shoot will cost \$100 per dancer. The photo shoot dates: Tuesday, October 3 rd , Friday, October 6 th and Saturday October 7 th . Dancers will be given a specific time and day.
<u>initial</u>	Mandatory "WINGS" Rehearsal dates: August 23 rd , 28 th , 30 th , along with September 5 th , 9 th , 16 th and 23 rd . Dancers will be given a specific time and day.
<u>initial</u>	I understand and will support the Dancer Agreement above and will work to be a positive influence as part of our participation in the UDA Ensemble program.
<u>initial</u>	I authorize UDA and/or Don Polo Photography to photograph/videotape the individual dancer listed above in promotional material.

Withdrawal from the program requires a personal meeting with the Program Director, in addition to **written notification of withdrawal** per the UDA class withdrawal policy. Note: Tuition refunds are subject to the UDA class withdrawal policy based upon the date of written withdrawal notification. Medical withdrawals will be handled on a case by case basis.

I have read, understand and agree to all the aforementioned information including the Drop Out/Withdrawal Fee schedule. I guarantee full payment of said fees if I withdraw my dancer from the UDA Ensemble Program after July 18th, 2017.
