## Dancer Agreement

<small>initial</small>	During Fall session I will <b>not exceed three</b> absences in my Conservatory rehearsal classes. And a <b>minimum of 90%</b> in my other required classes. Unless otherwise excused by the Conservatory Director. <i>This includes all Optional rehearsals if placed in an optional routine.</i>
<small>initial</small>	I Will Attend <b>ALL</b> Master Classes, Performances, and required meetings unless otherwise excused by program director.
<small>initial</small>	I will do my best to reach or exceed the maximum skill level of my team.
<small>initial</small>	I will be mindful of my weaknesses and will utilize my summer classes and jazz intensive classes to focus on overcoming them and creating strengths.
<small>initial</small>	I will have a strong work ethic and will effectively utilize all my dance classes and rehearsals to maximize my dance abilities.

## Parent Agreement

<small>initial</small>	<b>I HAVE READ AND UNDERSTAND ALL DATE REQUIREMENTS.</b> I understand that my dancer is expected to attend the June/August class commitments as well as, Fall dance camp (Epic), Fall class requirements, competitions, conventions and performances.
<small>initial</small>	<b>I Understand That Attendance is Extremely Important as Well as Arriving on Time to Class.</b> Participation affects not only my dancer, but all other dancers on my dancer's team.
<small>initial</small>	Conservatory dancers are only allowed to miss <b>three rehearsal</b> classes throughout the year.
<small>initial</small>	<b>I Understand That my Dancer is Required to Maintain at Least a 90% Attendance in All Other Conservatory Classes.</b> If your attendance falls below 90% or you <b>exceed three absences</b> from rehearsal, you will be placed on probations and a dancer/parent/director conference will be held to determine the appropriate consequences. These could include: 1.) Required makeup classes. 2.) Removal from routine/routines. 3.) Removal from the team.
<small>initial</small>	<b>I HAVE READ AND UNDERSTAND THE FEES SCHEDULE AND FINANCIAL REQUIREMENTS.</b> Including the withdrawal policy contained with this agreement.
<small>initial</small>	I understand that I will be <b>REQUIRED</b> to volunteer in some capacity during the year. This could include: team photographer, team mom, competition hostess, Starry Night helper, transport props, Critique helper etc.
<small>initial</small>	I will attend <b>ALL</b> Conservatory meetings to ensure I receive all information, schedules and training and that my child's Conservatory participation is not adversely affected due to my/our absence from mandatory meetings.

initial	I will maintain a working e-mail address, advising the Conservatory program manager with any updates so I may receive all Conservatory communications. I will check this address 2-3 times per week for updates during choreography and rehearsal months, and <b>daily</b> during the competition season. <u>I will provide all information requested throughout the season before required deadlines.</u>
initial	I understand and will support the Dancer Agreement above and will work to be a positive influence as part of our participation in the UDA competitive program.
initial	I authorize UDA and/or Don Polo Photography to photograph/videotape the individual dancer listed above in promotional material.
