Dancer Agreement

initial	I will treat my teammates with respect at all times. My words and actions will not adversely affect my fellow dancers. I understand that if I intentionally cause harm to a teammate it may be cause for immediate dismissal from the Varsity program,
initial	During Fall session I will not exceed two absences in my Varsity rehearsal classes. And a minimum of 90% in my other required classes. Unless otherwise excused by the Varsity Director. <i>The Optional routine rehearsals have a separate agreement.</i>
initial	I Will Attend ALL Performances and required meetings unless otherwise excused by program director. I understand that the Varsity year begins in June 2017 with the Jazz Intensive and concludes in June 2018 with the UDA Recital.
initial	I will do my best to reach or exceed the maximum skill level of my team. Including practicing and stretching at home.
initial	I will be mindful of my weaknesses and will utilize my summer classes and jazz intensive classes to focus on overcoming them and creating strengths.
initial	I will have a strong work ethic and will effectively utilize all my dance classes and rehearsals to maximize my dance abilities.

Parent Agreement

initial	I HAVE READ AND UNDERSTAND ALL DATE REQUIREMENTS. I understand that my dancer is expected to attend August session classes, Fall class requirements, competitions, choreography sessions and performances.
initial	I Understand That My Dancer is Expected to Attend the One Week Jazz Intensive session classes and the August session classes, Fall class requirements, competitions, choreography sessions and performances.
initial	I Understand That Each Month an Attendance Report will be sent to the Varsity Manager. If my dancer's attendance drops below 90%, I understand that a warning letter will be sent before my dancer is placed on probation.
initial	I Understand That if There is a Consistent Problem with my Dancer's Attendance being below 90%, a meeting will be held with the Varsity Director to discuss consequences for the attendance violation.
initial	I Understand That My Dancer CANNOT MISS Any Varsity Classes, During the Week of a Competition/Performance. Missing any class during the week of a competition/performance could result in my dancer being removed from a routine. This includes Saturday rehearsals prior to a competition weekend.
initial	I Understand That My Dancer is Allowed to Miss Two Varsity Rehearsals, Regardless Of Reason, as long as it is NOT during a competition/performance week. I also understand that if my dancer misses a third Varsity rehearsal it could result with my dancer being removed from competitions, performances or other events with the team. Senior Varsity team dancers are allowed THREE Varsity Rehearsal absences between their two rehearsal classes for the year.

initial	I HAVE READ AND UNDERSTAND THE FEES SCHEDULE AND FINANCIAL REQUIREMENTS. Including the withdrawal policy contained with this agreement. If my dancer does not complete the dance season by choice or by reason of dismissal, the withdrawal policy applies.
initial	I understand that I will be REQUIRED to volunteer in some capacity during the year. This could include photography, backstage mom, events, performances, team building activities, etc.
initial	I will attend ALL Varsity meetings to ensure I receive all information, schedules and training and that my child's Varsity participation is not adversely affected due to my/our absence from mandatory meetings.
initial	I will maintain a working e-mail address, advising the Varsity program manager with any updates so I may receive all Varsity communications. I will check this address 2-3 times per week for updates during choreography and rehearsal months, and <u>daily</u> during the competition season. <u>I will provide all information requested throughout the season before required deadlines.</u>
initial	I understand and will support the Dancer Agreement above and will work to be a positive influence as part of our participation in the UDA competitive program. I will also keep my comments and criticism positive when inside the walls of UDA (i.e. hanging out in the halls and watching classes).
initial	I authorize UDA and/or Don Polo Photography to photograph/videotape the individual dancer listed above in promotional material.

Note: Tuition refunds are subject to the UDA class withdrawal policy based upon the date of written withdrawal notification. Medical withdrawals will be handled on a case by case basis.
